#### **Updates**

#### Land Use

Kevin T attended council of councils meetings in Markham – real education re land use, bussed in Ontario Landowners' Association to protest land use restrictions

Ontario Nature and Environmental Defence conducted surveys that showed response on how people intend to vote based on how land is developed (or not)

Kevin presented Waterloo example of agricultural land coexisting with city land GREN members have sophisticated skills re presentations/working with councils

We need to get better at media work and political work

Recommendation to get all council votes to be recorded and all political donations to be transparent – Kevin will contact prof from York U who has studied connections between developers' money and politicians' voting

Should we be lobbying to stop developers donations to politicians?
