EXPLANATORY NOTE

Application in Conjunction: N/A

By-law 2012-035 passed by the Council of the Corporation of the City of Waterloo repeals the current Official Plan and adopts the proposed Official Plan for the City of Waterloo. The proposed Official Plan is the primary long range, comprehensive municipal planning document that outlines a framework for land-use decision-making for the City of Waterloo. The Plan is adopted by the City of Waterloo Council with input from the community and represents Council's vision for growth and change within the community, guided by the public interest. The area affected by the Plan constitutes all lands under the jurisdiction of the Corporation of the City of Waterloo.

The proposed Official Plan contains principles, objectives and policies designed to direct the form, extent, nature and rate of growth and change within the City of Waterloo and includes Chapters related to: Vision, Principles and Basis of the Plan, City Form; Arts, Culture, Heritage, Recreation and Leisure; Networks; Transportation; Economy; Environment and Energy; Mineral Aggregates; Land Use Policies; Specific Provision Areas; and, Implementation.
