# Notice Planning and Works Committee Meeting

## River Road Extension

### From King Street to Manitou Drive, City of Kitchener Class Environmental Assessment

### Recommended Design Alternative

The Regional Municipality of Waterloo is undertaking a Municipal Class Assessment (EA) study for the extension of River Road from King Street to Manitou Drive in the City of Kitchener. A Recommended Design Alternative – Concept 5 has been developed for this project that includes:


- 4-lane road with a continuous centre median and multi-use trails on both sides between King Street and Manitou Drive;
- Signalized intersection at the intersection of River Road at King Street;
- Full movements, signalized intersection at the intersection of Stonegate Drive/ Hwy 8 WB ramps with closure of the existing intersection of Stonegate Drive at King Street except for right-turn entry only from King Street;
- Unsignalized intersections of River Road at Hidden Valley Road and at the Hwy 8 EB ramp;
- Roundabouts at the intersections of River Road at Wabanaki Drive north of Goodrich Drive, Goodrich Drive at Wabanaki Drive and at Wilson Avenue; and
- Bridges across Schneider Creek and across Hwy 8 with ramps to access on and off Hwy 8 northbound, toward Waterloo and to access onto Hwy 8 southbound toward Cambridge.

The Regional Planning and Works will consider endorsing the Recommended Design Alternative at its regular meeting, to be held as follows:
