Thank you for your email response provided to me on Wed. December 21, 2016. It is appreciated.

I checked my emails and I have not received the July 27, 2016 correspondence that you referred to. May I secure a copy of the original email including date and time of when it was sent?

The reply that your agency sent to me on December 21, 2016, it states the following passage:

[Your complaint does not pertain to the Alberta Securities Act, therefore it is outside of the ASC's jurisdiction.](#)

I believe my complaint does pertain to the Alberta Securities Act in regards to the following policies:

*Securities Act Revised Statutes of Alberta 2000 Chapter S-4 Current as of May 27, 2016
Investigation order 41 (2) If an individual alleges under oath that a person or company has
contravened Alberta securities laws, the Executive Director may, by order, appoint a person to make
an investigation in respect of the allegation.*

The complaint I filed is already in the form of a sworn affidavit so it complies with the above regulation. Although my original application for review was made through the Ontario Securities Exchange it was forwarded to the Alberta Security Commission, with my permission, for the sake of securing an investigation with the appropriate jurisdictional agency. The Alberta Securities Act allows for anyone to submit concern regardless if they live in our out of the province of Alberta. It relates to this policy:

*Investigation order 41(1) The Executive Director may, by order, appoint a person to make any
investigation that the Executive Director considers necessary (a) for the administration of Alberta*

securities laws, (b) to assist in the administration of the securities or derivatives laws of another jurisdiction, (c) in respect of matters relating to trading in securities or derivatives in Alberta, or (d) in respect of matters in Alberta relating to trading in securities or derivatives in another jurisdiction.

Jurisdiction 31 The Commission has the jurisdiction to determine all questions of fact or law that arise in any matter before it. 1999 c15 s7

The reason I am filing a formal request for investigation is because I sincerely believe there was a possible violation of law that took place.

Disclosure reviews 60.2(1) The Executive Director may conduct a review of the disclosures required under Alberta securities laws that have been made or ought to have been made by an issuer, investment fund or credit rating organization.

My sworn evidence shows Imperial Oil's CEO published statements about CO2 in a corporate magazine that contradicts years of data found in their own research and reports. There was funding allocated by Exxon/Imperial specifically to produce data that contradicts the corporate findings. There was also non-disclosure of the risks associated with stranded assets.

I respectfully request a review by the Alberta Securities Commission regarding these issues.

My goal is to facilitate reasonable disclosure of risks in line with current knowledge and climate policies in order to mitigate risks for investors, pension funds, endowments and sovereignty funds in a manner that Honors the Crown and protects future generations.
