HIGHLIGHTING 50 YEARS OF CLIENT REPRESENTATION

CELA lawyers have represented thousands of clients in cases large and small. In so doing, we have shaped the jurisprudence of environmental law, including some of its most important precedents:

HUDSON, QUEBEC - Intervention at the Supreme Court of Canada to support municipal rights to protect citizens' health from needless pesticide use. This decision enabled a sea change in lawn and garden care across Canada, reducing some immediate sources of pesticide exposure.

ONCOMOUSE - Intervention at the Federal Court of Appeal and the Supreme Court of Canada. This decision denied the ability of anyone to patent mammals and other higher life forms as products under *Canada's Patent Act*.

WALKERTON INQUIRY - Representation of the Concerned Walkerton Citizens to advocate for a multi-barrier approach to protecting drinking water, redress the tremendous wrong done to this community, and require new or amended Ontario laws to protect drinking water.

HYDRO QUEBEC - Intervention at the Supreme Court of Canada to support the constitutional validity of federal toxics legislation. This decision upheld federal authority to protect the environment (not just human health) under criminal law powers, and made other legal findings that place the federal government's power to regulate toxic substances on solid ground.

LAFARGE - A landmark Ontario Divisional Court decision affirming important public participation rights under *Ontario's Environmental Bill of Rights*, including that Ontario must comply with its Statements of Environmental Values.

CASTONGUAY - Intervention at the Supreme Court of Canada to affirm use of international law principles, specifically the precautionary principle, in interpreting Ontario's *Environmental Protection Act*.

CELA has been instrumental in advancing or reforming an extensive body of law and international agreements over the last 50 years. Relying upon rigorous, non-partisan, and evidence-based analysis, we have worked in collaboration with colleagues and partner organizations, often as founding members of some of Ontario and Canada's most productive and innovative coalitions. These have included the Low Income Energy Network, RentSafe, Green Prosperity, the Toronto Cancer Prevention Coalition, and many others addressing issues such as Great Lakes protection, children's health, climate change, acid rain, pesticides and other toxic substances, and nuclear waste. While we can always do more, we are sure that Ontarians and Canadians are healthier and safer because of CELA's work.

50 years! As a CELA founder, I well know how long CELA has been doing its excellent work. Many of us involved in starting CELA were passionate about seeking innovative legal approaches, but we never imagined the lengths and depths of CELA's impact on Canada's environmental laws. A key development was to recognize environmental law as a matter of social justice, illustrated by CELA becoming a specialty clinic within the Legal Aid Ontario clinic system in 1978. Those most impacted by air pollution, unsafe water, or contaminated land are often the least able to avoid such threats. Across my environmental law career, I always paid attention to CELA's work, appreciating the "upstream" approach of identifying actions to improve underlying factors that contribute to environmental pollution. These issues are never easy. CELA respects that healthy communities include good jobs, healthy housing, and diverse aspects of social justice, making CELA's work with sister legal aid clinics, other service providers, health partners, and educators so important. As CELA moves towards this big milestone, I will continue to watch and appreciate the incredible work it undertakes, and feel very proud of the organization I was part of at the very beginning!
