Please note, no decision on the Official Plan review will be made on this meeting. A staff report recommending adoption of the updated City Official Plan will be scheduled for consideration at a future Council Meeting.

Purpose and Effect of the Proposed City Official Plan Amendment

The Official Plan provides city-wide direction on growth management, land use planning, and development related matters over the course of a 20–30-year timeframe. The purpose of the Official Plan Review is intended to provide a required update of the Official Plan policies and mapping to update the City Official Plan for consistency with legislation and current Provincial and Regional policies and plans.

The effect of the proposed Official Plan Review amendment will provide an updated policy framework for making land use planning decisions, including forecasted growth to 2051 and setting a structure for guiding growth, facilitating housing, and managing infrastructure. This mandatory update ensures that Official Plan policies stay current with Provincial plans and policy changes, conforms to the Regional Official Plan, and address local considerations and input from community consultations.

Notice of Decision and Appeals

If you wish to be notified of the decision of the Corporation of the City of Waterloo on the Official Plan Review update, you must make a written request to the City Clerk, Waterloo City Centre, 100 Regina Street South, Waterloo, Ontario, N2J 4A8.

If a person or public body would otherwise have an ability to appeal the decision of the Corporation of the City of Waterloo to the Ontario Land Tribunal but the person or public body does not make





oral submissions at a public meeting or make written submissions to the Corporation of the City of Waterloo before the proposed Official Plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Corporation of the City of Waterloo before the proposed Official Plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
