

NOTICE OF A FORMAL PUBLIC MEETING OFFICIAL PLAN AMENDMENT NO. 58, INCLUDING: CITY-INITIATED OFFICIAL PLAN REVIEW (PHASE 1) (CITY-WIDE)

Take notice that the Council of The Corporation of the City of Waterloo will hold a Formal Public Meeting, pursuant to Sections 17, 21 and 26 of the Planning Act, on Monday, December 2, 2024, at a time to be determined, in the Council Chambers, 3rd Floor, Waterloo City Centre, 100 Regina Street South, Waterloo, to consider the above-noted City-initiated Amendment to the Official Plan (2012).

PURPOSE AND EFFECT OF THE AMENDMENT

The Official Plan provides city-wide direction on growth management, land use planning, and development related matters over the course of a 20+year timeframe. The purpose of the Official Plan Review (Phase 1) is intended to provide a required update of the Official Plan policies and mapping to update the City Official Plan for consistency with legislation and current Provincial and Regional policies and plans.

At the Formal Public Meeting, the City Council will consider proposed OPA No. 58 that will provide an updated policy framework for making land use planning decisions and setting a structure for guiding growth, facilitating housing, and managing infrastructure.

Specifically, OPA 58 will:

- update and modify development policies and land use Schedules (maps) to the Official Plan to address local, regional and provincial planning requirements;
- update growth forecasts to the year 2051;
- include 'housekeeping' Amendments to the Official Plan to update and streamline policies as well as providing further clarification with regard to interpretation of the Official Plan in several areas; and,
- Defer a portion of the Official Plan in relation to the Laurel/Clair Creek SPA and certain lands identified on the land use Schedules (maps) to the Official Plan.

This meeting shall constitute the formal public meeting required under Sections 17, 21 and 26 of The Planning Act, R.S.O., 1990, as amended. It is expected that Council will decide whether the Cityinitiated Amendment No. 58 to the Official Plan should be approved, denied or amended.

If Council approves the proposed Amendment No. 58, a by-law to adopt the Official Plan Amendment will be passed.

When we receive your registration, we will send you a confirmation message and instructions for participating in the public meeting.

We encourage the public to provide input into these important Official Plan Amendment. The public is informed and notified that names, addresses and comments may be made public.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Corporation of the City of Waterloo before the by-laws are passed, the person or public body is not entitled to appeal the decision of Council to the Ontario Land Tribunal. In addition, if a person or public body does not make oral submissions at a public meeting, or make written submissions to the Corporation of the City of Waterloo before the by-laws are passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
