- ACTION ITEM FOR GREN MEMBERS:
 - Complete survey <u>www.civics.ca/ccid</u> or <u>www.civics.ca/ccid/surveys</u>; and/or Participate in workshop – either with REEP (June 29? during day) or just with GREN members – Beth will post email to list for feedback – would like 10 – 15 GREN members – we can pick our time, but should be done before fall
- Flexibility in amount of involvement, will be determined by this study, need community groups to confirm interest, some centres are theme-based (arts/environment)

<u>Updates</u>

<u>ROPP – Kevin</u>

- ROPP is very progressive 25 year plan for Region; province wants to use it as template
- Regional council approved, but deferred protected countryside line decision for 6 7 months pending further consultation (i.e. developers, farmers unhappy with the line claiming they weren't given adequate time/opportunities to comment/be informed)
- Our concern that it will mirror ESL process which was highly adversarial developers vs environmentalists
- Reminder that Region's 2003 Growth Management Strategy Plan already committed to "permanent countryside line"
- ACTION ITEM FOR GREN MEMBERS write letters, op/ed pieces in support of ROPP

Waterloo Golf Academy – Deb S.

- City of Waterloo did not renew their lease; not a breach of contract as some have claimed

<u>LRT</u>

- June 24 final vote, expected to pass, Waterloo spur will be on existing rail to U of Waterloo, NOT on King St., BRT to Cambridge
- Still getting negative press
- ACTION ITEM FOR GREN MEMBERS write supportive letters
- Point of interest in Dresden, the LRT is also used to transport freight to Volkswagon plant

Presentation: Carole Clinch Water Fluoridation

- Fluoride is toxic, bioaccumulative, provides no health benefit at levels ingested
- Timing and dosage are both critical; acute and chronic toxicities include dental fluorosis, thyroid problems, arthritic pain
- Halton is only community with stats shows 42% of children have dental fluorosis
- Naturally occurring fluoride is NOT used. Hydrofluosilicic acid, a hazardous, industrial waste chemical, contaminated with lead and arsenic is used. Ninety-nine percent of it is released into environment through our treated municipal water
- Dean study used to justify use has been re-evaluated and discredited cherry-picked data but use continues
- No difference in tooth decay/dental caries in communities with or w/o fluoridation

- City of Waterloo's upcoming referendum not legally binding Fluoridation Act cedes authority to upper tier
- Dental community is uneducated in issue
